


Town of West Terre Haute





III. New Issues (General)-


a. Lisa McCalister did the 1st Read of the Parks Board Ordinance.





III. New Issues (General)-


a. Emilee Woolley did the 2nd Read of the Parks Board Ordinance.




III. Legal Issues:
