- **d.** Lisa presented a proposal from Asset Solutions for them to come in and get our asset list completed correctly. The proposal amount is \$9,250.00, effective 6-12-2023. Larry made a motion to approve the proposal for \$9,250, Shane seconded the motion. 3-ayes
